- 1) (Bryan Prillaman) what is each members #1 goal in 2025, excluding the whole "wotc hiring a new JM, so maybe they will acknowledge us?"
 - Tob: revitalize conferences and ensure that judges feel like they are getting something out of Judge Foundry instead of just putting something in
 - Khailyn: My #1 goal in 2025 is to implement and empower community facing/focused projects utilizing voices of excitement, concern, and feedback.
 - Joe: My biggest goal is to have our organization land in a good place with regards to Wizards involvement in a judge program again. There are many options for how this goes, and I want to successfully guide us to a place that is good for our members.
 - Ryan: My hope is to achieve noticeable membership growth as well as increase engagement with and from the organization.
 - Rob: I would like to devolve more of the day-to-day operations of the organization to non-board members in a way that is sustainable going forward. The board does a lot of direct management and I'd like to get more community involvement in the organization.
- 2) (Bryan Prillaman) what is a thing the board accomplished last year that was successful. What did it learn from this success.
 - Joe: I don't want to claim that the biggest thing that we did in the last year was remove a
 bunch of judge levels, but maintenance was a huge undertaking. Update quizzes
 continue to be a big success as well. I think the real success is that we have stuck
 around long enough to show that we are legitimate. We certified/leveled up over 200
 judges in the last year. That's a big deal.
 - Rob: We hit a thousand members! This is a big deal, to have 1k paying members keeping the organization ongoing.
- 3) (Bryan Prillaman) what is a thing the board attempted and failed to accomplish last year. What did it learn from this failure.
 - Tob: We failed to ensure our members felt like judge foundry was providing anything of value. I think we learned that we can't just provide "sticks" like exams and maintenance, but we also need to provide carrots.

- 4) (Bryan Prillaman) A board should work together and form a cohesive whole. Using unified deck construction rules, what skills do you bring to the board.
 - Tob: I bring a sense of fun and a hard-working diligent attitude. I'm good at meeting deadlines and taking care of a lot of the boring backend work.
 - Joe: Aside from being here from the beginning and a sense of what this org should be, I think my biggest strength is the ability to bring together people for compromise. I want to hear lots of perspectives, and I'm good at finding middle ground.
 - Khailyn: I bring an obnoxious dedication, unique perspectives, lines of communication to multiple communities, and an emphasis on effective teaching and learning.
 - Ryan: One of the major qualities that I bring to the table is my experience with watching JF grow from before it started to now, and assisting with the FAB program growth. This experience will help illuminate what has worked and what has not.
 - Rob: I have a ton of history and institutional experience with historical judge programs. I'm the person that has been an RC, did selection for roles, and has a knowledge of why things were done that way in the past.

5) (Bryan Prillaman) which hypothetical explanation of the Fermi paradox do you feel is most plausible/believable
